VISTO el Decreto Nº 277/3(MEyP)-2024, la Resolución Nº 552/SH de fecha 13/04/2026 y la Instrucción Interna (DGR) Nº 4/26 de fecha 12/05/2026, y

CONSIDERANDO:

Que, en cumplimiento de las tareas encomendadas por las normas legales citadas en el Visto, la Comisión de Selección y Eliminación de Documentos ha identificado un total de 3008 (tres mil ocho) expedientes administrativos respecto a los cuales ha transcurrido, a la fecha, más de 10 (diez) años, contados a partir de su conclusión o bien del último trámite registrado, situación que condujo a su oportuno archivo;

Que a fs. 2 la Comisión de Selección y Eliminación de Documentos elabora el Acta Nº 1, de fecha 16/06/2026, dejando constancia de las circunstancias antedichas, la cual se encuentra suscripta por el órgano aludido y por las Jefaturas de los Departamentos Auditoría Interna y Control de Gestión, Técnico Tributario, Inteligencia Fiscal, Servicio Administrativo Financiero, Técnico Legal, Recaudación, Informática, Fiscalización, de las Divisiones Secretaría Institucional, Secretaría Privada y Control de Cobros Judiciales y de la Oficina Archivo;

Que a fs. 3/88 obra listado Anexo al Acta Nº 1, en el cual constan los datos de los expedientes sujetos al expurgo y destrucción;

Que, en relación al caso, se ha efectuado una clara individualización del contenido de los expedientes en cuestión, la cual contiene su número, fecha de generación, iniciador, objeto, cantidad de folios, actos administrativos emitidos –si los hubiere-, fecha de último trámite y todo otro dato de interés;

Que, asimismo, se ha verificado que las causas aludidas no están encuadradas dentro del listado de expedientes que no pueden destruirse, según el artículo 2º del Anexo I del Decreto Nº 277/3(MEyP)-2024;
